A Coincidence, Maybe By L. L. McCormick, O.D

For those of you on the outside looking in, this case is a coincidence: but for those of you who are syntonists, this case is a coincidence, maybe.

About a year ago when he writer first started practicing Syntonics, a boy twenty-two years old visited the office one day. The boy's complaint was that he could not see so well as he used to, an ordinary complaint to be sure. He also said his eyes tire some, ache and burn. In further questioning it was disclosed that the boy was a diabetic and had been for fifteen years, but other than that he was all right. He had never worn glasses and it had just been the past year that his eyes had gone bad. The author proceeded and found the unaided visual acuity to be 20/200 either eye and together. The lad's eyes are rather hollow set and have a squinting appearance. They are not alert, sparkling, eyes of a young man. The boy is medium in height and rather thin with large thick upper and lower lips, and a flat "pug" nose.

The external ocular reveal nothing of importance. The ophthalmoscopy was one of the most pathetic sights you could imagine. In the crystalline lens in both eyes were a frail maltese cross or stellar shaped opacities. These opacities were not opaque but quite easily seen. The vitreous relatively clear, but the fundus a mass of hemorrhages, and some exudates. Well, you can imagine the prognosis did not look too bright, but the examiner took the deck of cards and laid them on the table, with plenty of persuasion to try the treatments above everything else, first. It should be mentioned at this time that the #4 was 0.D. -2.75 0.S. -2.75 #5 0.D. -.75 0.S. -.75 #3 2 eso # 13A 10x0 #7 0.D. -2.50 – 100x110 0.S. -2.50 = 20/30 0.D. 20/60 0.S. 20/30. The rest of the 21 points are available, but now pertinent to this case.

RX#1 was given Bob for 5 applications and his vision improved to 20/100. RX #2 was given for 5 applications, and his vision improved to 20/100 +: It was at this point that the dilemma of what to treat the hemorrhages or the cataract became more than could be tolerated; consequently, a switch in frequencies was made. RX #3 was given the patient, and low and behold the hemorrhages began clearing. After a few more applications a switch back to #1 was made. After a few applications the hemorrhages began reoccurring. Of course, the author is aware of the fact that this patient could be hemorrhaging and the hemorrhages reabsorbing all by themselves without any Syntonics, hence the title of the article.

The patient was eventually improved to 20/90-2 unaided, and O.D. 20/25-2 O.S. 20/40 with O.D. -2.50-1.00x110 O.S. -2.25-50x70. The boy was asked to return for periodic checks, but said he was leaving for California.

Yesterday, Bob returned for a reexamination, with the complaint that he had gotten salt in his right eye and had rubbed his eye severely. Ever since then he has seen a spot with a tail on it and it moved with his eye. There had been some pain behind his eye, but it was better. He said he really believed the treatments had helped him a lot, that he could see almost as well without his glasses as he could with them. The author said to himself, that is a darn lie, the kid is just imagining things. Well he read O.D. 20/50 + O.S. 20/40 + 2 O.U. 20/30-1. He did not bring his glasses with him since he hardly ever wears them and when he does they pull his eyes.

The ophthalmoscopy revealed that a little of the opacity was still present in the right eye, but the left eye was clear. The fundus still had hemorrhages and one big one in the right eye just below the disc which was the one responsible for his complaint.

The author failed to mention above that Bob said after the first few applications that his eyes felt more rested did not ache and burn and he did not have to strain to see.

You may draw your own conclusions, but it is surely fun playing around with Syntonics, whether it is coincidental or not.

RX NL 4 Mu Delta 10 Delta Omega 6 Mu Pi 6 Mu Theta 4 or Mu Delta 4 #2 NL 4 theta 10 Mu Theta 10 Delta Omega 6 or Alpha Omega 6 Mu Theta 6 or Mu PI 6

I did not use always the same frequency, but varies them hence the <u>or</u>. #3 NL 4 Pi Omega 6 Mu Theta 6 Delta Omega 6

NL4 Alpha 6 Alpha Theta 6 Delta Upsilon 6 Mu Theta 8
