THE CLINIC AT THE COLLEGE

Many is the time you have wished for a place to which you could refer a definitely pathological patient with the assurance that it would be properly handled and at the same time have your own interests as the referring optometrist preserved.

Now this is all possible.

The <u>SPITLER CLINIC</u> at the college building has been so set up that all forms of pathological conditions can and will be taken care of by the latest approved methods of therapy. Patients having foci of infection which may be responsible for ocular pathosis can now be taken care of to the end of preservation of whatever vision may yet remain or the gain of better vision in many cases. Full reports will be made to the referring optometrist so that he may carry out his part of the work of restoring adequate visual function following any corrective work on pathological conditions cared for at the CLINIC.

The SPITLER CLINIC at the College is equipped to do electro-surgery upon any normally accessible part of the body for the purpose of eradicating and destroying focal conditions. The CLINIC is equipped to use diathermy, both medical and surgical, and the radiothermic methods now being accepted almost universally by the medical profession. Artificial fever therapy, electropyrexy, about which you have read much in the press, will also be administered to suitable cases requiring this form of treatment. The sine type electrical currents will be used to restore muscular activity in those cases of partial paralysis which are amenable to this form of treatment. Use will also be made of a tried method of electrical handling of opacities which are too far advanced for our syntonic method, but not yet far enough advanced to require surgical handling. This method, which is a relatively new therapy, has been successfully applied to a number of cases with gratifying results. Following its use, patients have been referred back to their syntonist for completion of the work begun by the manipulative methods of proved value, and provision has been made for the administration of such of these as may be of aid to the patient. Stress will be laid upon the use of selected photic range frequencies, including the Curay Ray Analytic, the Granz rays in cases in which these methods can be of value.

The CLINIC is located in the east wing of the College Building, corner of Franklin and St. Clair STs., Eaton, Ohio, and consists of eight specially designed treatment and office rooms. Address all correspondence, in reference to patients whom you might wish to refer, to SPITLER CLINIC, Eaton, Ohio. This will avoid delays in handling correspondence at the College. Incidentally, all doctors on the staff of the CLINIC are licensed by the Ohio State Board of Optometry, assuring your patient the attention of qualified practitioners. Technicians and internes at the CLINIC and are and will be specially trained for the type of work to be done.

The CLINIC will open for the reception, examination and taking care of referred patients on and after December 20th by the time you read this notice.

The officers and trustees feel certain that you'll be proud of this CLINIC when you see it and will be more than satisfied with the service it will render to you and your patient when you require it.

We've been asked how it is that the Clinic will treat or can treat pathological cases when they are referred by optometrists. The answer is that those who are on the clinic staff are properly licensed by the Ohio State and other Medical Boards to diagnose and treat diseases of the body as well as those of the eye by the methods in se at the CLINIC. These doctors have each had more or less twenty-five years experience, so you may feel safe in making references on the grounds of experience. The staff also includes experienced optometrists properly registered in Ohio.
