Continuing our practical application of Syntonic Optometry we present two additional and outstanding cases by our president Donald J. Mayer.

The first one is of unusual interest because he has successfully reduced myopia. In order that you will get the full meaning of this case it well be necessary to dwell on detail.

R. C. age 17. a senior in high school and the son of a well known physician. The stage is all set for an interesting, and if successful, a profitable experience. This is not all, there is a scholarship of four years if he can pass the vision requirement of Naval Officer's Reserve Corpse. The date is 12/8/1960. By mid April his vision must be 20/20, O.D., OS & O.U. Right eye now is 84 to 85% or 20/40-2. Left eye is 92% or 20/25-3. He wanted the best possible kind of corrective training as the improvement in vision was most urgent. Not only was the father interested, but the Navy as well.

He was given a pair of plus 1.25 spheres to be used for all near work, and twenty Syntonic applications. All frequencies were flashed. N/L 3, alpha delta 5, Mu delta 5, alpha theta S 8, mu theta S (last two frequencies on R. only. Alternate with N/L 3, (Flash all). Mu delta 5, delta theta 5, mu theta S 8, theta S. (last two right only). Unfortunately, there was an interruption of ten days, but on Feb. 13, he passed his Naval Reserve tests 20/20, O.D., O.S. & O.U. This is a good example of what Syntonics can do.

The second case was extremely disturbing. The objective was to give all possible assistance knowing that complete correction was impossible. The patient, C. H., a young man doing graduate work in the University of Arizona. A case of Bi-lateral Hemianopsia. One half of the visual field O. U. Also, Nystagmus. This the patient understands will never be entirely eliminated but the Hemianopsia has been corrected by Syntonics. The patient must have continued visual care and will be able to continue and complete his college work. The Rx. N/L 3, omega N.5, Mu upsilon 7, delta N 7, Mu upsilon D 8. alter. with (No nscen.) U5, mu upsilon5, upsilon D 8, mu epsilon D 8, upsilon omega D.5. EDITOR'S NOTE: In my opinion this young man has been the recipient of the finest optometric service available.
